The issues raised were many and diverse. These issues suggest that not only is there a need for more research and review, but even more important, further public input and consideration.

On June 8, 2010 the City of Vaughan Council adopted without amendment Item 3, Report No. 28, being the Committee of the Whole (Public Hearing) report of June 1, 2010, Zoning By-law Amendment File: Z.10.015 — Places of Worship City of Vaughan, a report to review current Zoning By-law 1-88 standards concerning places of worship and religious assembly with a view to examine whether the current zoning standards are appropriate and to advise Council on appropriate revisions as may be necessary;
